Giuliano BONOLI is Professor of Social Policy at the Swiss Graduate School for Public Administration (IDHEAP), Lausanne. He received his PhD at the University of Kent at Canterbury. He has been involved in several national and international research projects on various aspects of social policy. His work has focused on pension reform, labour market and family polices, with particular attention paid to the politics of welfare state transformation. He has published some forty articles and chapters in edited books, and recently the books: *The politics of the new welfare state* (Oxford University Press, 2012), with D. Natali, and *The origins of active social policy. Labour market and childcare policies in a comparative perspective* (Oxford University Press, 2013).

Rui BRANCO is Assistant Professor at the Department of Political Studies, Nova University of Lisbon. His research interests center on comparative state formation, civil society and social policy. His more recent work has focused on civil society and democratization in new democracies, social policy and welfare civil society in Southern

Europe, and fiscal welfare and inequality in Portugal. He is a member of the research network "Fiscal Welfare-Political economy of fiscal welfare policies" (SciencesPo/LIEPP). He has recently co-edited a special issue of the *Journal of Comparative Politics* on "Civil Society and Democracy in an Era of Inequality" (2017, forthcoming).

Begoña CUETO is Associate Professor in the Department of Applied Economics of the University of Oviedo (Spain). Her research is related to labour economics, the evaluation of public policies, the labour market situation of people with disabilities and entrepreneurship. She regularly participates in projects funded by national and regional authorities (Regional Public Employment Services and the Ministry of Employment) to analyse the labour market (evaluation of training, analysis of the situation of particular groups). At the moment, she works in the European project STYLE. She usually publishes articles in international journals such as *International Journal of Manpower*, *Papers in Regional Economics*, *Applied Economics* or *Applied Research in Quality of Life*.

Margarita ESTÉVEZ-ABE is Associate Professor of Political Science, Maxwell School of Citizenship and Public Affairs (Syracuse University) and Research Fellow at Collegio Carlo Alberto in Torino. She has also taught at the University of Minnesota, Keio University in Japan and Harvard University. She grew up in Japan and Spain. She did her undergraduate work at Keio University in Japan and earned her PhD in political science from the Government Department at Harvard University. She is particularly interested in gender, social policy, political institutions and varieties of capitalism. Her first book, Welfare and Capitalism in Postwar Japan (Cambridge University Press, 2008) was the winner of the 2009 Masayoshi Ohira Memorial Award.

Sergio GONZÁLEZ BEGEGA is a Senior Lecturer in the Department of Sociology of the University of Oviedo. He has been involved in several EU research projects including the Excellence Network RECWOWE (FP6) and the integrated project bEUcitizen (FP7). His research lines include Europeanization of social policy and European industrial relations, with an emphasis on labour interest's representation in transnational firms, social dialogue and industrial conflict. He has published book chapters in edited books with Edward Elgar, Routledge, PIE Lang or Rainer HamppVerlag, among others. He has also published articles in journals such as Employee Relations, European Journal of Social Security, REIS, RIS, RES, Empiria and Sociología del Trabajo.

María C. GONZÁLEZ-MENÉNDEZ is Associate Professor of Sociology at the University of Oviedo (Spain). Her active research interests include workers' participation, gender and employment, labour management, and the role of sub-national socioeconomic governance systems in the attraction and retention of multinational firms. Recent publications include the book *Women on Corporate Boards and in Top Management. European Trends and Policy* (Palgrave, 2012), co-edited with Colette Fagan and Silvia Gómez, and the handbook on HRM in Spain *Gestión de Recursos Humanos: Contexto y Políticas* (Thomson-Civitas, 2011), co-edited with Rodolfo Gutiérrez and Miguel Martínez Lucio. She is currently co-leader of the work package on *Policy Transfer and Comparative Frameworks* within the large scale FP7 project Strategic Transitions for Youth Labour in Europe.

Ana M. GUILLÉN is full professor of Sociology and Head of Department at the University of Oviedo (Spain). Her research interests include welfare state development, comparative social and labour policy, political economy and the process of Europeanisation and European integration. She has acted as a consultant to the European Commission and several EU presidencies. Ana has also served as vice-president of the executive board of Research Committee 19 of the International Sociological Association and of the ESPAnet Board (European Social Policy Analysis Network). Currently, she co-chairs ESPAnet-Spain, Recently, she has co-edited special issues of South European Society and Politics (vol. 19, no. 3, 2014) and European Journal of Social Security (vol. 17, no.2, 2015).

Rodolfo GUTIÉRREZ is Professor of Sociology at the University of Oviedo (Spain). He graduated with a PhD in Sociology from the Complutense University of Madrid. From 2002 to 2007 he was Director of Research Unit at the Economic and Social Council of Spain. His main research fields are economic sociology, socioeconomic inequality, language and migration, and comparative social policy. He has co-edited, with Neil Fraserand Ramón Peña-Casas the book *Working Poverty in Europe. A Comparative Approach* (Palgrave-Macmillan, 2011).

Holm-Detlev KÖHLER is Professor of Sociology at the Department of Sociology, University of Oviedo (Spain) and associated professor of the Centre for Cooperation and Local Development at the same university. His main research interests include comparative industrial relations, management and innovation in transnational corporations, local and regional development. Co-author of the main handbook on Sociology of Work and Industrial Relations (with Antonio Martín Artiles), in Spanish

Manual de la Sociología del trabajo y de las Relaciones Laborales (Delta Publicaciones, 3rd edition 2010). His most recent publications in English are "Reconstruction and restoration: the legacies of post-war German Industrial Sociology" (Work, Employment and Society, 1/2016) and "They don't represent us!" Opportunities for a Social Movement Unionism Strategy in Spain" (Relations Industrielles/Industrial Relations, vol. 70 (2), 2015).

F. Javier MATO-DIAZ is an Associate Professor at the Department of Applied Economics in the University of Oviedo (Spain). He holds a PhD in Economics from Oviedo, and a MSc in European Social Policy from the London School of Economics. His main research deals with the analysis of labour market and related policies. He has published on issues like evaluation of training for the unemployed, analysis of traineeships for young people, immigrants' labour market outcomes, and unemployment protection programmes.

Martin SEELEIB-KAISER is Barnett Professor of Comparative Social Policy and Politics Professorial Fellow of St Cross College at the University of Oxford. Prior to Oxford, he held appointments at the Universities of Bremen and Bielefeld (Germany) as well as Duke University (North Carolina, USA). His research focuses on the politics of social policy and comparative social policy analysis. He has worked on the relationship between globalization and welfare systems, political parties and the welfare state, the interplay between 'public' and 'private' social protection policies and associated processes of dualization and more recently on social rights of EU citizens. He has coedited (with P. Emmenegger, S. Häusermann and B Palier the book *The Age of Dualization*. New York/Oxford: Oxford University Press, 2012) and, more recently, he has published articles in journals such as *Social Policy and Society, Politics and Society, Social Politics, Social Policy and Administration*.
