Héctor CEBOLLA (hcebolla@poli.uned.es) is an Associate Professor at UNED (Department of Sociology - Social Stratification) in Madrid (Spain). He holds a Ph.D. in Sociology from the University of Oxford (Nuffield College, UK) and the Juan March Institute (Madrid, Spain). His research seeks to understand how migrant status determines educational and health outcomes among children of migrants and migrant children. More substantively his work deals with perinatal inequalities, cognitive and non-cognitive outcomes, educational careers and returns to education. He is interested in quantitative techniques and their methodological implications.

Begoña CUETO (bcueto@uniovi.es) is Associate Professor in the Department of Applied Economics of the University of Oviedo (Spain). Her research is related to labour economics, the evaluation of public policies, the labour market situation of people with disabilities and entrepreneurship. She regularly participates in projects funded by

national and regional authorities (Regional Public Employment Services and the Ministry of Employment) to analyse the labour market (evaluation of training, analysis of the situation of particular groups). At the moment, she works in the European project STYLE. She usually publishes articles in international journals such as *International Journal of Manpower*, *Papers in Regional Economics*, *Applied Economics* or *Applied Research in Quality of Life*.

Her research activities are mainly related to economic inequality, sustainable development and economic forecasting. She has been visiting fellow at some universities of UK, Hungary, Cuba and Portugal and she works as an expert evaluator for the European Commission Lifelong Learning Programme, through the Spanish National Agency (SEPIE).

Prior to joining CBS, Caroline was Associate Professor at Roskilde University (2013-2015) and at the University of Southern Denmark (2007-2013). Ana M. GUILLÉN (aguillen@uniovi.es) is full professor of Sociology at the University of Oviedo (Spain). She has acted as a consultant to the European Commission and several EU presidencies. Ana has also served as vice-president of the executive board of Research Committee 19 of the International Sociological Association and of the ESPAnet Board (European Social Policy Analysis Network). Rodolfo GUTIÉRREZ (rgutier@uniovi.es) is Professor of Sociology at the University of Oviedo (Spain). He graduated with a PhD in Sociology from the Complutense University of Madrid. From 2002 to 2007 he was Director of Research Unit at the Economic and Social Council of Spain. His main research fields are economic sociology, socioeconomic inequality, language and migration, and comparative social policy. He has co-edited, with Neil Fraser and Ramón Peña-Casas the book *Working Poverty in Europe. A Comparative Approach* (Palgrave-Macmillan, 2011).

Bea CANTILLON (bea.cantillon@uantwerpen.be) is Professor of Social Policy and Director of the Herman Deleeck Centre for Social Policy at the University of Antwerp, Belgium. She has published widely and internationally on a wide range of issues relating to poverty, social policy, social security, the welfare state, and gender. She has acted as a consultant to, among others, the OECD, the European Commission and the Belgian government. Next to being the Chair of FAMIFED - Federal Agency for Child benefits, she also served as a Belgian senator (1995-1999) and was the president of the National Reform Commission on the Belgian Social Security for independent workers (2000-2002). Prof. Cantillon is secretary-general of the Foundation for International Studies on Social Security. As of 2003 she is also a Fellow of the Royal Belgian Academy and member of the Belgian High Council for Employment. Since 2013 she is a member of the commission on pension reform 2020-2040. Prof. Cantillon served as a Chair of the

General Assembly UFSIA (2002-2003) and as vice-president of the University of Antwerp (2004-2008). The Centre for Social Policy, linked to Prof. Bea Cantillon, has been recognized as a center of excellence under the Flemish Methusalem program, granting substantial long-term structural financing to support internationally recognized scientific research.

Sergio GONZÁLEZ-BEGEGA (gonzalezsergio@uniovi.es) is a Senior Lecturer in the Department of Sociology of the University of Oviedo. He has been involved in several EU research projects including the Excellence Network RECOWE (FP6) and the integrated project bEUcitizen (FP7). His research lines include Europeanization of social policy and European industrial relations, with an emphasis on labour interest's representation in transnational firms, social dialogue and industrial conflict. She is currently co-leader of the work package on *Policy Transfer and Comparative Frameworks* within the large scale FP7 project Strategic Transitions for Youth Labour in Europe.

Emmanuele PAVOLINI (emmanuele.pavolini@unimc.it) is Associate Professor in Economic Sociology and Social Policy at the University of Macerata (Italy). As an economic sociologist he has focused his research interests in two fields. The main one is comparative welfare state studies. He has extensively published in Italian and English on: the Italian welfare state in comparative perspective; Southern European welfare states; specific social policies (family policies, elderly care / LTC, child care, social care and health care and, more recently, education); in inequalities in the access to welfare state provision; occupational welfare; welfare mix and third sector organizations. A second field of research is related to the functioning of the labour market, economic development and enterprises' behaviours.
